Description

This series consists of petitions and associated documents, such as affidavits, filed with the Supreme Court in relation to the Lunatics Act.

Under the Lunatics Act, the Court was granted the power to make orders regarding the maintenance of dependents and the care and management of property and estates of individuals found incapable of managing their own affairs due to mental illness.

Documents within the series may include statements by relatives and medical practitioners giving details of the financial situation and illness of the individual.
