Company files may contain some or all of the following lodged documents: Memorandum of Agreement, Articles of Association, Certificate of Incorporation, lists of shareholders, lists of directors, special resolutions ie. issues of shares, underwriting agreements and annual returns.

Note: The term 'defunct' should not be understood to refer to the company. In this context it refers to the file being defunct, although given the age of the records some of the companies will have become defunct.
